Terms and Conditions of Al Singapore Courses

1. Registration

- 1.1. Registration of Al Singapore courses is through our website https://reg.aisingapore.org/ai4i
- 1.2. The data provided will be used for course administration including the conduct of any course-related surveys. The data may also be disclosed to relevant organisations that require the information such as partners, certification awarding bodies, examination agencies, and funding agencies.

2. Payment

- 2.1. Any registration of a course will only be confirmed upon receipt of full payment by Al Singapore. Payment of course fees is at registration.
- 2.2. Payment of course fees constitutes acceptance of the terms and conditions herein. Payment can only be made via our online payment system.
- 2.3. You will not be placed in the course unless payment is received 7 working days prior to course commencement.

3. Course Confirmation

- 3.1. The course confirmation is based on the declaration that:
 - a. You are a Singapore Citizen / Permanent Resident
 - b. You are 17 years old and above
 - c. For placement in the AI4I Practical Foundations in AI with Python course, you are required to complete the "Intro to Python for Data Science" with at least (3525 XP score) 75% of total XP score
- 3.2. The course confirmation shall be withdrawn if it is found that you do not satisfy the eligibility criteria.
- 3.3. In event that the course confirmation is withdrawn due to inaccurate and untruthful declaration by you, Al Singapore shall withdraw the course confirmation without any refund of the course fee paid or any recourse to the participants.

4. Changes and Modifications

- 4.1. Al Singapore course schedules including course content, course fees and course availability are subject to change.
- 4.2. Your recourse in the event of any changes stated in paragraph 3.1, is limited to one of the following:



- 4.2.1. Enroll in the same course with a later start date. If there has been a change in course fees for the same course, you will pay to Al Singapore the difference between the fees.
- 4.2.2. Enroll in another course conducted by AI Singapore. If the fees of the replacement course selected costs more than what has already been paid to AI Singapore, you will pay to AI Singapore the difference between the fees. Conversely if fees of the replacement course selected cost less than what has already been paid to AI Singapore, AI Singapore will make a refund of the difference to you.
- 4.2.3. Withdraw from the course. Al Singapore will make a full refund of the fees if you have already paid the fees

5. Cancellation and Refunds

- 5.1. If Al Singapore cancels a class: Al Singapore reserves the right to cancel any class at its absolute discretion without assigning any reason for such cancellations. In the event that your class is cancelled prior to its commencement, Al Singapore will make a full refund of all course and assessment/examination fees (if any) already paid by you.
- 5.2. If you cancel a registration: All cancellation requests must be received in writing. If notice of cancellation is given:
 - a. Fourteen (14) working days or more before class starts 100% refund of all course and assessment/examination fees (if any) paid.
 - b. Seven (7) working days or less before class starts 50% refund of all course and assessment/examination fees (if any) paid.
 - c. "No-show" on first day of class or after class start date No refund of all course and assessment/examination fees (if any) paid.

7. Completion of Course and Issuance for Certificates

- 7.1. The AI Singapore certificate will be issued to participants who have:
 - a. successfully completed the course (including all assessments and projects where applicable). For the issuance of the certificate for Al4I Practical Foundations in Al with Python course, you are required to complete "Data Scientist with Python" track with 75% of total XP (ie 74,783 XP out of 99,710 XP); and
 - b. achieve 75% attendance in the face-to-face sessions.
